

The <u>Bay Ridge Storefront Arts Walk (SAW)</u>, an annual event in its 7th year, was created in 2010 by local artist and business owner John Avelluto of the <u>The Owl's Head Wine Bar</u> and business owner Heather Hamilton of <u>Long's Wine & Liquors</u>. SAW was formed as a way to showcase the diverse community of Bay Ridge and give it a unique platform for engagement and dialogue with the visual arts. By supporting and promoting emerging local artists and celebrating local Bay Ridge businesses, SAW broadly explores the intersection between commerce, art, and

community while raising awareness for the arts in the underserved neighborhood of Bay Ridge.

This year the opening celebration will be on Saturday, May 14th and installations will be up through June 25.

Arts Advocacy Day 2016 Recap



The 29th annual Arts Advocacy Day (March 7 - 8) brought together a broad cross section of America's cultural and civic organizations to underscore the importance of developing strong public policies and appropriating increased public funding for the arts.

U.S. Senator Tom Udall (D-NM) introduced the "Comprehensive Resources for Entrepreneurs in the Arts to Transform the Economy Act" (CREATE Act) at Arts Advocacy Day. The legislation "recognizes the power of the creative economy and helps artists, entrepreneurs and communities continue to grow and create jobs and opportunities.
